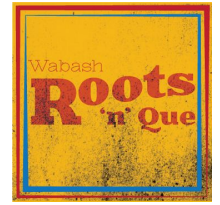

2. The following music genres are acceptable for this year's competition: **Traditional Blues, Bluegrass, Ethnic, Old-Time Country, Folk.**
3. Registering person will be responsible for all aspects of participation in the competition
4. Only those songs listed on the entry form may be performed
5. Each entrant (single or group) will have an absolute maximum 10 minutes performing time. Please be sure the length of the two songs does not exceed the limit, including time between songs.
6. A list of judging criteria will be available prior to scheduled performance time.
7. Winner will be announced on the RNQ Main Stage between 4:45pm and 5:15pm.
